Assessments and Collections

The Office of the State Public Defender (OPD) has a state special revenue account that receives funds from sources authorized under 47-1-110. One of the sources of funds are payments for the cost of a public defender ordered by the court pursuant to 46-8-113 as part of a sentence in a criminal case.

The courts provide OPD with summary information as to the assessments made by each court for the cost of public defender services. The assessment amounts received during FY 2016 are on the accompanying Attachment A. The agency uses this information to record a lump sum accounts receivable.

The courts also provide OPD with summary information as to their collection of the assessed fees by each court. The amounts received by the courts during FY 2016 are contained on the accompanying Attachment B.

The agency uses the amount actually deposited by the Department of Revenue through the County Collection Process (not the amount reported by the courts in Attachment B) to record a lump sum revenue and a reduction of its accounts receivable balance. There is a variance between the courts' reporting and the timing of the actual deposit to OPD's state special revenue account.

OPD does not receive information from the courts or the Department of Revenue by client.

OPD also receives a small amount of funds directly from clients at the Central Services Office in Butte.
